Contractors will be pre-qualified into a tiered system of small, medium and large service providers consisting of the following criteria:

- i. Small contractors are those with a fleet of five trucks or less.
- ii. Medium contractors are those with a fleet of between six trucks and fifteen trucks.
- iii. Large contractors are those with a fleet of sixteen trucks and more.
