## Introducing .....

### **Electrification Programme (EP)**

The Ministry of Public Utilities is committed to the provision of a safe and reliable supply of electricity services to the citizens of Trinidad and Tobago; and is aimed at improving their social and economic welfare through the provision of electricity services. The Ministry is assisting low income citizens in accessing an electricity supply through the delivery of the Electrification Programme.

### **The Programme will comprise.....**

The provision of electricity poles and the associated electrical infrastructure (Transformers, Low Voltage lines) to residences and communities through the Trinidad and Tobago Electricity Commission (T&TEC)

### **How to Apply:**

- Completed Application Form
- Copy of Identification Card - (ID/DP/Passport)
- Copy of Land Document - (Deed of Title)
  - i. In the event that the owner of the land has died, the applicant must present a death certificate and a letter of administration certifying that he / she has permission to conduct business of any sort on the land.
  - ii. If the deed does not belong to the applicant, he/she must provide a letter from the owner of the land giving T&TEC permission to install the necessary electrical infrastructure on the land. The applicant must also provide a valid copy of the Identification Card of the owner.
  - iii. Copy of Land Document for persons squatting on State lands (Certificate of Comfort or Letter of non-objection from State Agency/Enterprise).
- Letter of estimated cost from T&TEC (outlining cost of electrical infrastructure e.g. poles, Transformers, Low Voltage lines, Streetlights etc.)

### **General Criteria.....**

All applicants must satisfy the following criteria to be eligible for the Electrification Programme:

1. The applicant must be a legal resident or citizen of Trinidad and Tobago;
2. The applicant requiring electrification must submit the estimated Capital Contribution cost from T&TEC
3. The applicant must show proof of residency
4. The applicant must provide proof of legitimacy to occupy the lands on which the residence is located.
