The Scope of Works for the plant includes Design, Supply, and Installation of a fully Automated Package Water Treatment Plant and equipment, inclusive of all civil, processes, mechanical, electrical, controls and Instrumentation requirements. The plant should be designed to produce 20,457 m³ /day (4.5 IMGD). It also includes testing and commissioning, supply of four (4) copies of O&M manuals and "AS BUILT" drawings for interconnecting pipework, appurtenances and equipment supplied. Supply and installation of Communication Networks from the plant to WASA's Head Office OCC (Operation Control Centre). Additionally, the Contractor is to provide operation and maintenance services for a period of one (1) calendar year following completion of the works.

This Invitation for Bids follows the General Procurement Notice for this project that appeared in Development Business No. **IDB -IDB-P2053226-08/23** of August 29, 2023.

The Government of the Republic of Trinidad and Tobago has received a loan from the Inter-American Development Bank (IDB) in the amount equivalent to US\$80M, toward the cost of the National Water Sector Transformation Programme, and it intends to apply part of the proceeds of this loan to payments under the contract for the Design-Build of the Santa Cruz (Green Meadows) Water Treatment Plant.

The National Insurance Property Development Company Limited (NIPDEC) now invites sealed bids from eligible bidders for the Design-Build of the Santa Cruz (Green Meadows) Water Treatment Plant. The Santa Cruz Plant is located at Saddle Road (Green Meadows) Santa Cruz.

The works involve Design, Supply, and Installation of a fully Automated Package Water Treatment Plant and equipment, inclusive of all civil, processes, mechanical, electrical, controls and Instrumentation requirements. The plant should be designed to produce 20,457 m³ /day (4.5 IMGD). It also includes testing and commissioning, supply of four (4) copies of O&M manuals and "AS BUILT" drawings for interconnecting pipework, appurtenances and equipment supplied. Supply and installation of Communication Networks from the plant to WASA's Head Office OCC (Operation Control Centre). Additionally, the Contractor is to provide operation and maintenance services for a period of one (1) calendar year following completion of the works. The delivery/construction period is 546 calendar days (18 months) following the Commencement Date.

This Request for Bids (RFB) will be conducted through the international competitive bidding procedures specified in the Inter-American Development Bank's Policies for The Procurement of Works and Goods Financed by The Inter-American Development Bank and is open to bidders from all countries as defined in the guidelines.

Bids will be opened publicly in the presence of bidders' representatives and anyone who chooses to attend at the address below at **14.30 hours Trinidad and Tobago time, on Monday, December 18, 2023**.
