The Government of the Republic of Trinidad and Tobago has received financing from the Inter-American Development Bank (IDB), towards the cost of the Trinidad and Tobago National Water Sector Transformation Program. The Ministry of Public Utilities (MPU), the executing agency of the Borrower, intends to apply a portion of the proceeds of this loan to eligible payments under the contract for the consultancy identified below. Payments by the Bank will be made only at the request of the Ministry of the Public Utilities and upon approval by the Bank and will be subject, in all respects, to the terms and conditions of the loan contract.

The Ministry of Public Utilities now invites suitably qualified Attorneys-at-Law to indicate their interest in providing the following consulting service as follows (hereinafter called "Services"):

Advisory Services to Develop Legislation for the Establishment of the Office of Water Resources Management at the Ministry of Public Utilities

The Attorney-at-Law Consultant will be required to develop the legal and regulatory framework to facilitate the movement of water resources management functions from within the Water and Sewage Authority of Trinidad and Tobago (WASA) into the Office of Water Resource Management (OWRM), a unit within the MPU with economic regulatory oversight by the Regulated Industries Commission (RIC). The consultant will also be required to provide legal advice on the institutional structure, governance arrangements, and decision-making processes of the OWRM.
